OKLAHOMA DEPARTMENT OF TRANSPORTATION DISTRICT 4 WINS 2024 PERPETUAL PAVEMENT AWARD

The Asphalt Pavement Alliance (APA) announced today that the Oklahoma Department of Transportation District 4 has won a 2024 Perpetual Pavement by Conversion Award for I-40 from milepost 112 to milepost 119 in Canadian County.

The Perpetual Pavement by Conversion award honors agencies that demonstrate outstanding design and construction practices, specifically in constructing new asphalt roads over existing roads. To qualify for this prestigious award, the converted pavement must meet Perpetual Pavement design criteria: the completed project must have asphalt mixture binder and surface layers and be at least two miles in length--municipal roadways must be at least 1,200 feet in length. A National Center for Asphalt Technology engineer evaluated the nominations and validated the winners.

The Oklahoma Department of Transportation District 4 received the award for the rehabilitation of a 7-mile stretch of I-40 in Canadian County. The project addressed cracking and rutting of the existing asphalt on this thoroughfare serving an average of 27,300 vehicles daily. Contractors first milled the existing surface, then installed a highly modified asphalt (HiMA) rich intermediate layer designed to mitigate cracking, followed by HiMA mix with a larger aggregate size for enhanced resilience. The surface was completed with stone matrix asphalt. This use of HiMA technology which incorporates higher polymer content than conventional modified asphalt—enhances the pavement's durability and performance. The road was opened to traffic in 2023, providing motorists with a smoother, longer-lasting Perpetual Pavement roadway.

"Asphalt roads can be designed, built, and maintained to indefinitely prevent deep distresses," said Dr. Buzz Powell, P.E., Technical Director of the APA. "The resulting Perpetual Pavement structure is an excellent investment for taxpayers because it only requires periodic surface renewal, has the most preservation options, and never requires reconstruction. Advantages of Perpetual Pavements include durability, economics, sustainability, and smoothness. The smoothness advantage of asphalt pavements is indefinitely extended with Perpetual Pavement since deep distresses that cause roughness never occur."
